**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING FEES AND CHARGES FOR SERVICES PROVIDED BY THE POLICE
DEPARTMENT**

WHEREAS, the City of Elk Grove adopted the fees and charges of police services provided by the Sacramento County Sheriff's Department when the City incorporated in 2000; and

WHEREAS, the City of Elk Grove established its own police department in July 2006 and retained the services of the consulting firm, Revenue & Cost Specialists, LLC to conduct an analysis of the Elk Grove Police Department's fees and charges; and

WHEREAS, Revenue & Cost Specialists, LLC conducted an analysis of the Elk Grove Police Department's fee-based services based on 2004-05 salary and staffing data; and

WHEREAS, the Police Fee Study submitted by Revenue & Cost Specialists, LLC has been updated to reflect 2008-09 salary and staffing data; and

WHEREAS, the cost analysis methodology used by Revenue & Cost Specialists, LLC remained the same in the updated fee study worksheets.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves fees and charges for police services outlined in Exhibit A.


