

**RESOLUTION NO. 2008-212**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH PACIFIC  
EXCAVATION INC. IN THE AMOUNT OF \$116,506 TO FURNISH CITY STANDARD  
ZONE 2 ELECTROLIERS FOR THE SHELDON ROAD / STATE ROUTE 99  
INTERCHANGE RECONSTRUCTION PROJECT**

**WHEREAS**, reconstructing the existing Sheldon Road / State Route 99 interchange is a high priority for the City and is currently under construction; and

**WHEREAS**, the Sheldon Road / State Route 99 Interchange Reconstruction Project (Capital Improvement Project ID PT0010) is included in the approved 2008-2013 Capital Improvement Program and is budgeted within the approved Fiscal Year 2008-09 budget; and

**WHEREAS**, City standard decorative Zone 2 electroliers (street lights) have been planned for installation on the Interchange bridge and approaches to the bridge; and

**WHEREAS**, this material is designated to be City Furnished Material for installation by the contractor; and


**WHEREAS**, an invitation to bid was duly advertised on August 6, 2008, for purchase of said electroliers; and

**WHEREAS**, the bid was opened on August 19, 2008 and Pacific Excavation Inc., the only bidder, was determined to be the responsible bidder submitting the lowest responsive bid; and

**WHEREAS**, the project budget has sufficient funds for this contract award.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Pacific Excavation Inc. in the amount of \$116,506 to furnish 22 City Standard Zone 2 Electroliers for the Sheldon Road / State Route 99 Interchange Reconstruction Project.




