

**RESOLUTION NO. 2008-221**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE TO APPROVE THE FISCAL YEAR 2007-08 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)**

**WHEREAS**, the City of Elk Grove has applied for and received Community Development Block Grant (CDBG) funds as an entitlement jurisdiction from the Government of the United States under Title I of the Housing and Community Development Act of 1974; and

**WHEREAS**, the Department of Housing and Urban Development (HUD) is the federal agency that promulgates regulations and oversees the administration of the CDBG program; and

**WHEREAS**, HUD requires that entitlement jurisdictions complete an annual evaluation of their grants programs through a report known as the Consolidated Annual Performance and Evaluation Report or CAPER; and

**WHEREAS**, staff has completed the 2007-08 CAPER; and


**WHEREAS**, a public notice announcing the availability of the CAPER and the 15-day public comment period for the report was published on August 22, 2008; and

**WHEREAS**, the 15-day public comment period has closed and the CAPER has been considered by the Elk Grove City Council.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove:

1. Approves the 2007-08 Consolidated Annual Performance and Evaluation Report (CAPER); and
2. Authorizes the City Manager to submit the CAPER to the Department of Housing and Urban Development; and
3. Allows staff to make technical modifications to the CAPER to correct minor errors or as required by HUD.




