**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE 2008-13 CAPITAL IMPROVEMENT PROGRAM AND THE FISCAL
YEAR 2008-09 BUDGET BY APPROVING THE ALLOCATION OF \$3,683,000 OF
ECONOMIC STIMULUS FUNDING FOR THE ANNUAL PAVEMENT RESURFACING
PROGRAM, INTELLIGENT TRANSPORTATION SYSTEMS PROGRAM, AND THE
I-5 / ELK GROVE BOULEVARD NORTHBOUND ON-RAMP PROJECT**

WHEREAS, President Obama signed the American Recovery and Reinvestment Act into law on February 17, 2009; and

WHEREAS, the Sacramento Area Council of Governments (SACOG) mobilized and completed an exhaustive selection process, identifying high priority road and transit projects that could quickly use the economic stimulus funding; and

WHEREAS, among the projects approved by SACOG are critically needed transit and road projects in the City of Elk Grove (City); and

WHEREAS, with the City's excellent track record in delivering transit and roadway projects, the City was successful in securing \$3,683,000 for roadway projects that will improve road mobility; and

WHEREAS, this resulted in \$115,000 of Gas Tax fund savings from the I-5 / Elk Grove Boulevard project that can be transferred to the Annual Pavement Resurfacing Program.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the 2008-13 Capital Improvement Program and the Fiscal Year 2008-09 budget as follows:

- 1) Annual Pavement Resurfacing Program (Capital Improvement Project ID PT0035) – Adds \$2,483,000 in Federal Economic Stimulus Funding and adds \$115,000 in Gas Tax Funds;
- 2) Intelligent Transportation Systems Program (Capital Improvement Project ID PT0084) – Adds \$1,000,000 in Federal Economic Stimulus Funding; and
- 3) I-5 / Elk Grove Boulevard Northbound On-ramp Project (Capital Improvement Project ID PT0086) – Adds \$200,000 in Federal Economic Stimulus Funding and reduces Gas Tax funds by \$115,000.


