

**RESOLUTION NO. 2009-166**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING STAFF TO SUBMIT ENTRY SIGN PROPOSALS  
TO THE CALTRANS GATEWAY MONUMENT PROGRAM  
FOR THE SHELDON ROAD / STATE ROUTE 99 AND  
GRANT LINE ROAD / STATE ROUTE 99 INTERCHANGES**

**WHEREAS**, on April 23, 2008, the City Council adopted the City and Community Entry Sign Program and directed staff to proceed with signs at the Sheldon Road and Grant Line Road Interchange projects, with the remaining signs to be implemented as funding becomes available; and

**WHEREAS**, the California Department of Transportation (Caltrans) has re-initiated its Gateway Monuments Program in 2009, setting forth criteria and guidelines for entry signs; and

**WHEREAS**, Caltrans has notified the City that proposals from local jurisdictions are being considered for entry signs on freeways and interstates; and

**WHEREAS**, staff has identified the entry sign location and design for submittal to the Caltrans Gateway Monuments Program as part of the landscaping projects for the Sheldon Road and Grant Line Interchanges on State Route 99; and


**WHEREAS**, the proposed entry sign locations and design were presented to the Elk Grove City Council; and

**WHEREAS**, the design of the signs includes size specifications that take advantage of the maximum allowable size for entry signs under the Caltrans guidelines; and

**WHEREAS**, the proposed signs and locations will undergo review by various Caltrans departments, and in case substantive design changes are requested by Caltrans, staff will bring back to Council any significant design changes and seek further direction.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes staff to submit an entry sign proposal to the Caltrans Gateway Monument Program for the Sheldon Road / State Route 99 and the Grant Line Road / State Route 99 Interchanges.
