

**RESOLUTION NO. 2009-242**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT  
SERVICES CONTRACT AMENDMENT WITH PB AMERICAS, INC. FOR THE  
SHELDON ROAD / STATE ROUTE 99 INTERCHANGE RECONSTRUCTION  
PROJECT TO EXTEND THE TERM OF THE CONTRACT THROUGH JULY 31, 2010  
AND INCREASE THE CONTRACT AMOUNT BY \$162,979 FOR  
A TOTAL NOT TO EXCEED AMOUNT OF \$2,631,602**

**WHEREAS**, the City of Elk Grove and PB Americas, Inc. (PB Americas) entered into a contract for the Sheldon Road / State Route 99 Interchange Reconstruction Project on October 26, 2007 (Contract No. C-07-467); and

**WHEREAS**, consistent with the contract scope, adjustments with PB Americas staffing levels would keep in pace with construction needs throughout the 2-year construction phase and also be modified when City provided some of these services; and

**WHEREAS**, the City requires additional construction management services to be provided under this amendment and this necessitates an increase to the contract amount by \$162,979; and

**WHEREAS**, this budget related contract amendment can be accommodated within the approved project budget; and

**WHEREAS**, the original contract is scheduled to expire on March 31, 2010 and will also need to be amended to extend the term through July 31, 2010.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a consultant services contract amendment with PB Americas, Inc. for the Sheldon Road / State Route 99 Interchange Reconstruction Project to amend the existing contract to extend the term through July 31, 2010 and to increase the contract amount by \$162,979, resulting in a total not-to-exceed contract amount of \$2,631,602.
