**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO SIGN A SALES AGREEMENT WITH  
CLEAN ENERGY FOR COMPRESSED NATURAL GAS (CNG) AND AUTHORIZING  
PAYMENT OF \$225,000 IN ENERGY EFFICIENCY AND CONSERVATION BLOCK  
GRANT FUNDING AS THE CITY'S CONTRIBUTION TO THE CONSTRUCTION OF A  
PUBLIC FAST-FILL CNG FUELING FACILITY ON ELKMONT WAY, UPON RECEIPT  
FROM THE UNITED STATES DEPARTMENT OF ENERGY**

**WHEREAS**, the City of Elk Grove has a critical need for fast-fill Compressed Natural Gas (CNG) infrastructure to fuel the Transit fleet; and

**WHEREAS**, the City's fleet is alternatively fueled in compliance with the California Air Resources Board fleet requirements; and

**WHEREAS**, on May 27, 2009 the City Council authorized the City Manager to sign a Memorandum of Understanding with Clean Energy to develop a public-private partnership for CNG fueling in Elk Grove; and

**WHEREAS**, the Sales Agreement with Clean Energy will be for 10-years and is renewable; and

**WHEREAS**, the City has received funding for Energy Efficiency and Conservation Block Grant projects and on May 27, 2009 the City Council approved \$225,000 for a public-private CNG partnership.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to sign a Sales Agreement with Clean Energy for Compressed Natural Gas upon receipt of the grant from the United States Department of Energy; and

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove authorizes payment of \$225,000 in Energy Efficiency and Conservation Block Grant funding as the City's contribution to the construction toward the capital costs of a public Fast-Fill Compressed Natural Gas Fueling Facility on Elkmont Way in the City of Elk Grove.
