

**RESOLUTION NO. 2010-50**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE FISCAL YEAR 2009-10 STREET MAINTENANCE DISTRICT NO. 1 ZONE 2 BUDGET TO REFLECT AN ADDITIONAL \$7,000 IN FORMATION REVENUE AND EXPENDITURES**

**WHEREAS**, the City Council of the City of Elk Grove adopted Resolution No. 2004-54 approving the application fee for annexation into Street Maintenance District No. 1; and

**WHEREAS**, the fee is for cost recovery of expenses related to annexation; and

**WHEREAS**, a project has duly paid its required annexation fees, has voted upon and been annexed into the District; and

**WHEREAS**, the annexation fees created an additional \$7,000 in revenue for the District that had not previously been programmed within the Fiscal Year 2009-10 budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2009-10 Street Maintenance District No. 1 Zone 2 budget to reflect an additional \$7,000 in formation revenue and expenditures as follows:
