

**RESOLUTION NO. 2010-51**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH  
FEENEY WIRELESS FOR THE PURCHASE OF REPLACEMENT POLICE VEHICLE  
COMPUTERS IN AN AMOUNT NOT TO EXCEED \$450,000**

**WHEREAS**, the Elk Grove Police Department has 124 sworn officers and more than 75 police fleet vehicles equipped with computers; and

**WHEREAS**, law enforcement officers out in the field depend on data accessed from their vehicles to perform their duties; and

**WHEREAS**, the standard life expectancy of police vehicle computers is three years; and

**WHEREAS**, the computers currently in use have exceeded their life expectancy; and


**WHEREAS**, the maintenance on computers that have exceeded their life expectancy tends to be excessive and cost prohibitive; and

**WHEREAS**, staff conducted a competitive bid process to find the most qualified and best price; and

**WHEREAS**, there is sufficient funding identified and budgeted in Fiscal Year 2009-10 fund numbers 102-000-422-60.01 and 602-1843-418.62-00 for this purchase.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an agreement with Feeney Wireless for the purchase of replacement police vehicle computers in an amount not to exceed \$450,000.


