

**RESOLUTION NO. 2010-98**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION  
CONTRACT WITH GRANITE CONSTRUCTION COMPANY FOR THE ASPHALT  
CONCRETE OVERLAY AND CURB RAMP IMPROVEMENTS 2010 PROJECT IN  
THE AMOUNT OF \$1,906,609 AND AUTHORIZING THE CITY ENGINEER TO  
APPROVE CHANGE ORDERS NOT TO EXCEED \$191,000**

**WHEREAS**, as part of the City of Elk Grove's (City) Annual Capital Pavement Resurfacing Program, the City performs various surface treatments throughout the City to maintain the quality of its streets; and

**WHEREAS**, the Asphalt Concrete Overlay and Curb Ramp Improvements 2010 Project (Capital Improvement Project ID PT3510 and PT5810) (Project) is included in the approved 2009-14 Capital Improvement Program and is budgeted within the approved Fiscal Year 2009-10 Budget; and

**WHEREAS**, an invitation to bid was duly advertised on April 9, 2010, bids were opened on May 4, 2010, and Granite Construction Company was determined to be the lowest responsible bidder submitting the lowest responsive bid.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Finds that the project is exempt from environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Title 14 of the California Code of Regulations Section 15301(c); and
- 2) Authorizes the City Manager to execute a construction contract with Granite Construction Company for the Asphalt Concrete Overlay and Curb Ramp Improvements 2010 Project in the amount of \$1,906,609 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney and the Risk Manager; and
- 3) Authorizes the City Engineer to approve change orders not to exceed \$191,000.
