**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE COMMUNITY DEVELOPMENT BLOCK GRANT ACCESSIBILITY
CURB, GUTTER AND SIDEWALK IMPROVEMENTS PROJECT AS COMPLETE AND
AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO
FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY
RECORDER**

WHEREAS, on October 28, 2009, the City Council authorized the award of a construction contract to FBD Vanguard Construction for the Community Development Block Grant (CDBG) Accessibility Curb, Gutter and Sidewalk Improvements Project (Project) (Capital Improvement Project ID PT0097); and

WHEREAS, the Project provided for improvements and installation of sidewalk and handicap ramp facilities in various locations throughout the Old Town residential neighborhood; and

WHEREAS, FBD Vanguard Construction has completed the work in accordance with the contract documents for the project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amounts due will be released to FBD Vanguard Construction.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Community Development Block Grant Accessibility Curb, Gutter and Sidewalk Improvements Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the project with the Sacramento County Recorder.


