A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE REPEALING RESOLUTION NO. 2010-123 AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACTS, REPORTS AND OTHER DOCUMENTS REQUIRED FOR RECEIVING 2009 STATE HOMELAND SECURITY GRANT PROGRAM FUNDS

WHEREAS, Sacramento County Office of Emergency Services administers the State Homeland Security Grant Program; and

WHEREAS, funding for the State Homeland Security Grant Program originates with the Federal Emergency Management Agency (FEMA); and

WHEREAS, the Elk Grove Police Department's proposal for emergency equipment was selected by the Sacramento County Office of Emergency Services for funding; and

WHEREAS, there is sufficient funding in the Police Department's budget to satisfy a grant match in the amount of \$4,945; and

WHEREAS, the granting agency requires that the City's governing body approve acceptance of the award and designate an authorized signatory to grant award documents.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove as follows:

- 1) The City Manager is hereby authorized to accept a grant award in the amount of \$37,133 under the 2009 State Homeland Security Grant Program;
- 2) The City Manager is hereby authorized to execute all contracts, reports, and other documents required for receiving such funds pursuant to the terms and conditions of the 2009 State Homeland Security Grant Program;
- 3) The City Manager is hereby authorized to amend the Police Department's revenue and expense budget in the amount of \$37,133. Revenue and expense budgets shall be amended as follows to reflect receipt of federal grant funding:
