

**RESOLUTION NO. 2010-179**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE FREEWAY MAINTENANCE  
AND LANDSCAPE MAINTENANCE AGREEMENTS WITH CALTRANS FOR THE  
GRANT LINE ROAD / STATE ROUTE 99 AND SHELDON ROAD / STATE ROUTE 99  
INTERCHANGES**

**WHEREAS**, the City of Elk Grove has completed and accepted the Grant Line Road / State Route 99 interchange project; and

**WHEREAS**, the City of Elk Grove is in the final stages of completing the construction of the Sheldon Road / State Route 99 interchange project; and

**WHEREAS**, the City of Elk Grove desires to install a Gateway City Entrance Monument and landscaping at both of the aforementioned interchanges; and

**WHEREAS**, prior to proceeding with the landscaping and gateway monument projects, Caltrans requires the City to execute Freeway Maintenance and Landscape Maintenance Agreements in order to prescribe maintenance obligations and levels of service.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager, or designee, to execute four separate agreements with Caltrans for:

- 1) Freeway Maintenance at Grant Line Road / SR 99 Interchange
- 2) Landscape Maintenance at Grant Line Road / SR 99 Interchange
- 3) Freeway Maintenance at Sheldon Road / SR 99 Interchange
- 4) Landscape Maintenance at Sheldon Road / SR 99 Interchange
