**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPOINTING HOWARD SIHNER AS THE OLD TOWN ELK GROVE FOUNDATION
MEMBER TO THE HISTORIC PRESERVATION COMMITTEE**

WHEREAS, on January 24, 2007 the City Council adopted Ordinance No. 3-2007 enacting the Historic Preservation Ordinance for the purpose of promoting the general welfare and economic and social vitality of the people and City of Elk Grove by providing for the identification, designation, protection, enhancement, perpetuation and use of historic resources including buildings, structures, objects, sites, districts, and cultural landscapes within the city that reflect special elements of the city's heritage and cultural diversity; and

WHEREAS, Elk Grove Municipal Code (EGMC) Section 7.00.040(B) establishes the appointment of members to the Historic Preservation Committee which shall consist of seven (7) regular members and one (1) alternate member; and

WHEREAS, a vacancy for the Old Town Elk Grove Foundation regular member position currently exists; and

WHEREAS, the Old Town Elk Grove Foundation endorses the applicant Howard Sihner as their representative nominee; and

WHEREAS, all appointments to the Historic Preservation Committee shall be by vote of not less than three (3) Council Members.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby appoints Howard Sihner as the Old Town Elk Grove Foundation representative member to the Historic Preservation Committee.
