

RESOLUTION NO. 2010-200

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH HOBLIT
MOTORS FOR THE PURCHASE OF FIVE POLICE PATROL UNITS IN AN AMOUNT
NOT TO EXCEED \$125,000**

WHEREAS, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements when necessary; and

WHEREAS, the City's Fleet division has identified five patrol vehicles that have reached their useful life and require replacement; and

WHEREAS, pursuant to Elk Grove Municipal Code Chapter 3.42, the City Council may waive the competitive bidding process when the purchase is processed through a cooperative purchasing agreement with another public agency whose procurement process is consistent with the City of Elk Grove; and

WHEREAS, the State of California opened a competitive bidding process for the purchase of police patrol vehicles, and Hoblit Motors met all of the criteria and was selected as the lowest responsive bidder; and

WHEREAS, the Fleet division has sufficient funding indentified in its Fiscal Year 2010-11 operating budget for this purchase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Hoblit Motors for the purchase of five police patrol units in an amount not to exceed \$125,000.


