

RESOLUTION NO. 2010-201

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING RESOLUTION NO. 2010-172, AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE OFFICE OF TRAFFIC SAFETY IN THE AMOUNT OF \$245,000 AND AMENDING THE POLICE DEPARTMENT'S BUDGET

WHEREAS, In February 2010, the Office of Traffic Safety announced funding opportunities for local law enforcement agencies interested in implementing selective traffic enforcement programs that heighten awareness of the dangers of driving under the influence; and

WHEREAS, the Office of Traffic Safety originally awarded the Elk Grove Police Department a grant in the amount of \$170,000 to implement programs to reduce the number of people driving under the influence; and

WHEREAS, the Office of Traffic Safety has increased the Elk Grove Police Department's grant award to \$245,000 to include speed and exhaust enforcement operations.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution, amending Resolution No. 2010-172, authorizing the City Manager to: 1) accept grant funding from the Office of Traffic Safety in the amount of \$245,000; and 2) amend the Police Department's Fiscal Year 2010-11 revenue and expense budgets as follows:
