A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH HEMINGTON LANDSCAPE SERVICES, INC. FOR THE WILLIAMSON DRIVE SIDEWALK IMPROVEMENTS PROJECT IN THE AMOUNT OF \$78,219 AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$23,500

WHEREAS, the Williamson Drive Sidewalk Improvements Project (Capital Improvement Project ID PT0133) is included in the approved 2010-15 Capital Improvement Program and is budgeted within the approved Fiscal Year 2010-11 Budget; and

WHEREAS, an invitation to bid was duly advertised on August 25, 2010 and bids were opened on September 24, 2010; and

WHEREAS, Hemington Landscape Services, Inc. was determined to be the responsible bidder submitting the lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Finds that the Williamson Drive Sidewalk Improvements Project is exempt from environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Title 14 of the California Code of Regulations Section 15301(c); and
- Finds that an Environmental Assessment leading to a Finding of No Significant Impact (EA/FONSI) was completed for the Williamson Drive Sidewalk Improvements Project pursuant to 24 CFR 58.36 and the National Environmental Policy Act; and
- 3) Authorizes the City Manager to execute a construction contract with Hemington Landscape Services, Inc. for the Williamson Drive Sidewalk Improvements Project in the amount of \$78,219 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and
- 4) Authorizes the City Engineer to approve change orders not-to-exceed \$23,500; and
- 5) Finds that should Hemington Landscape Services, Inc. fail to meet their obligations in executing the construction contract, the City Manager is thereby authorized to execute a construction contract with B&M Builders, Inc. (second lowest responsible bidder) in the amount of \$87,757.99 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney and authorizes the City Engineer to approve change orders not-to-exceed \$26,500.
