**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE FRANKLIN BOULEVARD / ELK GROVE BOULEVARD
INTERSECTION AND BUS TURNOUTS WIDENING PROJECT AS COMPLETE AND
AUTHORIZING THE CITY ENGINEER TO PREPARE A NOTICE OF COMPLETION
AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE
SACRAMENTO COUNTY RECORDER**

WHEREAS, on April 14, 2010, the City Council authorized the award of a construction contract to DeSilva Gates Construction, Inc. to construct the Franklin Boulevard / Elk Grove Boulevard Intersection and Bus Turnouts Widening Project (Capital Improvement Project ID PT0001) (Project); and

WHEREAS, DeSilva Gates Construction, Inc. has completed the work in accordance with the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to DeSilva Gates Construction, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Franklin Boulevard / Elk Grove Boulevard Intersection and Bus Turnouts Widening Project (Project) as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Clerk-Recorder.
