**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE BOND ROAD AT EAST STOCKTON BOULEVARD  
AND ELK GROVE BOULEVARD AT LAGUNA SPRINGS DRIVE MEDIAN  
ISLAND IMPROVEMENTS PROJECT AS COMPLETE AND AUTHORIZING  
THE CITY ENGINEER TO PREPARE A NOTICE OF COMPLETION AND  
THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE  
SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on July 14, 2010, the City Council awarded a construction contract to Biondi Paving, Inc. to construct the Bond Road at East Stockton Boulevard and Elk Grove Boulevard at Laguna Springs Drive Median Island Improvements Project (Capital Improvement Project ID PT0107 and PT0119) (Project); and

**WHEREAS**, the Bond Road at East Stockton Boulevard Median Island Improvement Project included the installation of delineators approximately 150 feet west of East Stockton Boulevard and a raised median from the existing median end to the existing crosswalk at the intersection; and

**WHEREAS**, the Elk Grove Boulevard at Laguna Springs Drive Median Island Improvements Project included the installation of cobblestone within the existing median curb to improve the overall appearance of the median; and

**WHEREAS**, Biondi Paving, Inc. has completed the work in accordance with the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained funds and any remaining amount due will be released to Biondi Paving, Inc.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Bond Road at East Stockton Boulevard and Elk Grove Boulevard at Laguna Springs Drive Median Island Improvements Project (Project) as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Clerk-Recorder.
