

**RESOLUTION NO. 2010-261**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
INCREASING THE CITY ENGINEER'S AUTHORITY TO EXPEND CONTINGENCY  
FUNDS FOR THE WILLIAMSON DRIVE SIDEWALK IMPROVEMENTS PROJECT  
BY \$23,000 FOR A TOTAL NOT-TO-EXCEED AMOUNT OF \$46,500**

**WHEREAS**, the Williamson Drive Sidewalk Improvements Project (Project) is a high priority for the City that will improve pedestrian safety by providing a safe path of travel along Williamson Drive from Elk Grove Boulevard to the Elk Grove Adult Community Training (EGACT) buildings; and

**WHEREAS**, on October 13, 2010, City Council adopted a resolution authorizing the City Manager to execute a construction contract with Hemington Landscape Services, Inc. for the Project in the amount of \$78,219 and authorizing the City Engineer to expend contingency funds in the amount of \$23,500 for additional costs beyond the construction contract (Resolution No. 2010-206); and

**WHEREAS**, staff anticipates an additional \$23,000 in contingency is needed to complete the Project; and

**WHEREAS**, the proposed new contingency amount totals \$46,500 and includes additional roadway base repair due to damage to the road from construction operations as well as to accommodate the placement of crosswalk pavement markings and other unforeseen miscellaneous changes.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby increases the authority of the City Engineer to expend contingency funds for additional project costs beyond the construction contract for the Williamson Drive Sidewalk Improvements Project by \$23,000, a change from \$23,500, for a total not-to-exceed amount of \$46,500.


