A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE SHORT RANGE TRANSIT PLAN TO INCLUDE THE COMMUTER AND FIXED ROUTE FLEET PLAN, ADDING THE CORPORATION YARD IMPROVEMENT PROJECT(S) AND BUS REPLACEMENT PROGRAM TO THE CAPITAL PROJECTS LIST FOR FISCAL YEARS 2010-11, 2011-12, AND 2012-13 AND AUTHORIZING THE CITY MANAGER TO SUBMIT AND EXECUTE GRANT APPLICATION AND/OR AWARD DOCUMENTS FOR PTMISEA (6361-0002) SAFETY AND SECURITY FUNDING FOR THE CORPORATION YARD SAFETY AND ACCESS IMPROVEMENTS PROJECT

WHEREAS, the City of Elk Grove operates a comprehensive transit system; and

WHEREAS, the Federal Transit Administration requires transit agencies to maintain current Short Range Transit Planning documents; and


WHEREAS, the State of California requires all projects submitted for Public Transportation Modernization, Improvement, and Service Enhancement Account Program (PTMISEA) funding to be included in a current Short Range Transit Plan; and

WHEREAS, the City of Elk Grove wishes to apply for capital funding necessary to upgrade the safety and security of the Corporation Yard.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Short Range Transit Plan to include the updated Commuter and Fixed Route Fleet Plan and adds the Corporation Yard Improvement Project(s) and Bus Replacement Program to the Capital Projects List for Fiscal Years 2010-11, 2011-12 and 2012-13.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to submit and execute grant application and/or award documents for Public Transportation Modernization, Improvement, and Service Enhancement Account Program (PTMISEA) (6361-0002) Safety and Security funding for the Corporation Yard Safety and Access Improvements Project.
