

**RESOLUTION NO. 2011-111**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH  
SACRAMENTO COUNTY ENVIRONMENTAL MANAGEMENT DIVISION (EMD) FOR  
MANDATED REGULATORY COMPLIANCE INSPECTIONS REQUIRED BY THE  
NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES)  
STORMWATER PERMIT FOR A PERIOD OF FOUR YEARS**

**WHEREAS**, the City of Elk Grove along with other co-permittee agencies has been issued a National Pollutant Discharge Elimination System (NPDES) Stormwater Permit by the Regional Water Quality Control Board; and

**WHEREAS**, one of the permit's requirements is to track, inspect, and ensure compliance with stormwater ordinances at commercial and industrial facilities; and


**WHEREAS**, the Sacramento County Environmental Management Division (EMD), as both the State-designated Certified Unified Program Agency (CUPA) and the Environmental Health Agency for Sacramento County, is currently tracking and inspecting the majority of commercial and industrial facilities subject to NPDES permit provisions; and

**WHEREAS**, the cost of the program is 100% funded through fees assessed to the regulated businesses; and

**WHEREAS**, the original agreement, with amendment, will expire on June 30, 2011.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an agreement with Sacramento County Environmental Management Division (EMD) for fulfilling the National Pollutant Discharge Elimination System (NPDES) permit inspection requirements for a period of four years to expire June 30, 2015.
