

RESOLUTION NO. 2011-112

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION
CONTRACT WITH BIONDI PAVING, INC. FOR THE NEIGHBORHOOD LIVABILITY
SPEED CONTROL IMPROVEMENT PROJECT (PT0077) IN AN AMOUNT NOT-TO-
EXCEED \$65,300 AND AUTHORIZING THE CITY ENGINEER TO APPROVE
CHANGE ORDERS IN AN AMOUNT NOT-TO-EXCEED \$13,100**

WHEREAS, the City Council adopted a Speed Control Program in November 2008; and

WHEREAS, the Neighborhood Livability Speed Control Improvement Project (PT0077) (Project) is a project that was developed under the Speed Control Program; and

WHEREAS, funding for the Project is from Fiscal Year 2008-2009 Gas Tax; and


WHEREAS, the current available budget for the Project is \$104,400; and

WHEREAS, an invitation to bid was duly advertised on April 20, 2011, bids were opened on May 19, 2011, and Biondi Paving, Inc. was determined to be the lowest responsible bidder submitting the lowest responsive bid for the Project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Finds that the Speed Control Improvement Project (PT0077) (Project) is exempt from environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Title 14 of the California Code of Regulations Section 15301(c); and
- 2) Authorizes the City Manager to execute a construction contract with Biondi Paving, Inc. for the Project in the amount of \$65,300 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and
- 3) Authorizes the City Engineer to approve change orders for the Project in an amount not-to-exceed \$13,100.


