

RESOLUTION NO. 2011-133

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT
AMENDMENT WITH INTER-STATE OIL COMPANY, INC. TO PURCHASE BULK
UNLEADED GASOLINE AND CARD LOCK FACILITY FUEL FOR CITY VEHICLES
BY EXTENDING THE CONTRACT FOR A ONE YEAR TERM AND AUTHORIZING
AN EXPENDITURE OF FUNDS NOT-TO-EXCEED \$750,000 [FOR A TOTAL
EXPENDITURE OF FUNDS OVER THREE YEARS NOT-TO-EXCEED \$2,250,000]**

WHEREAS, the City provides police services, transit services, code enforcement and integrated waste management vehicles within the City of Elk Grove requiring the use of unleaded gasoline and diesel fuel for daily operation; and

WHEREAS, on or around July 28, 2010, the City amended and extended the contract with Ferrellgas / Elk Grove Gas & Oil; and

WHEREAS, on or around July 30, 2010, Ferrellgas / Elk Grove Gas & Oil sold its business operations including the operations pertaining to the goods and services covered under the contract and First Amendment to Inter-State Oil Company, Inc.; and


WHEREAS, an Assumption Agreement was entered into by the City and Inter-State Oil Company, Inc.; and

WHEREAS, the City has engaged Inter-State Oil Company, Inc. to provide the City with bulk and card lock facility fuel; and

WHEREAS, Inter-State Oil Company, Inc. has satisfactory provided bulk and card lock facility fuel to the City.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to amend the contract with Inter-State Oil Company, Inc. for bulk and card lock facility fuel for City vehicles, extending the contract for a one year term and authorizing an expenditure of funds not-to-exceed \$750,000 [for a total expenditure of funds over three years not-to-exceed \$2,250,000].


