**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE NEIGHBORHOOD LIVABILITY (SPEED CONTROL)  
IMPROVEMENT PROJECT AS COMPLETE AND AUTHORIZING THE CITY  
ENGINEER TO PREPARE, AND THE CITY CLERK TO FILE, THE NOTICE OF  
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on June 22, 2011, the City Council awarded the construction contract to Biondi Paving, Inc. to construct the Neighborhood Livability (Speed Control) Improvement Project (Capital Improvement Project ID PT0077) (Project); and

**WHEREAS**, the Neighborhood Livability (Speed Control) Improvement Project will address the citizens' speeding concerns on Pleasant Grove School Road, Toscano Drive, Sierra River Drive, Stathos Drive, Clarke Farms Drive, and Sierra Street by installing speed tables / humps with signing and striping; and


**WHEREAS**, Biondi Paving, Inc. has completed the work in accordance with the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Biondi Paving, Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Neighborhood Livability (Speed Control) Improvement Project (Capital Improvement Project ID PT0077) (Project) as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion for the Project and authorizes the City Clerk to file the Notice of Completion with the Sacramento County Recorder.
