**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPOINTING RODERICK BREWER AND DAVIES ONONIWU TO THE
SACRAMENTO REGIONAL HUMAN RIGHTS / FAIR HOUSING COMMISSION
ADVISORY BOARD**

WHEREAS, the Sacramento Human Rights / Fair Housing Commission was formed in 1963, the result of a joint powers agreement between the City and the County of Sacramento to promote harmony among the various groups in the Sacramento community; and

WHEREAS, with the adoption of Resolution Nos. 2007-35 and 2008-62 the City Council of the City of Elk Grove entered into a Joint Exercise of Powers Agreement with the Sacramento Human Rights / Fair Housing Commission; and


WHEREAS, members of the Sacramento Regional Human Rights / Fair Housing Commission Advisory Board shall serve no more than two consecutive three year terms; and

WHEREAS, on March 25, 2009 the Council appointed Roderick Brewer, and on May 13, 2009 the Council appointed Davies Ononiwu, as citizen representatives to the Sacramento Regional Human Rights / Fair Housing Commission Advisory Board for three year terms; and

WHEREAS, the three year terms will expire March 25, 2012 and May 13, 2012 respectively, and both Mr. Brewer and Mr. Ononiwu have confirmed their wishes to continue to represent the City of Elk Grove in the capacity as a citizen representatives on the Sacramento Regional Human Rights / Fair Housing Commission Advisory Board, and staff have confirmed they continue to meet all qualification requirements.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby appoints Roderick Brewer and Davies Ononiwu to the Sacramento Regional Human Rights / Fair Housing Commission Advisory Board to serve second, and final, three year terms, effective March 25, 2012 and May 13, 2012, respectively.


