**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE GRANT LINE ROAD / STATE ROUTE 99 INTERCHANGE AND  
SHELDON ROAD / STATE ROUTE 99 INTERCHANGE LANDSCAPING PROJECTS  
PT009L AND PT010L AS COMPLETE AND AUTHORIZING THE CITY ENGINEER  
TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION  
WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on October 13, 2010 the City Council authorized the award of a construction contract to Watkins and Bortolussi, Inc. to construct the Grant Line Road / State Route 99 Interchange and Sheldon Road / State Route 99 Interchange Landscaping Projects (Capital Improvement Project Nos. PT009L and PT010L) (Project); and

**WHEREAS**, the Project provided for the installation of planting materials and irrigation systems, minor site improvements including installation of Gateway Monument Entrance signs at both interchanges; and


**WHEREAS**, Watkin and Bortolussi, Inc. has completed the work in accordance with the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Watkins and Bortolussi, Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Grant Line Road / State Route 99 Interchange and Sheldon Road / State Route 99 Interchange Landscaping Projects as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
