

RESOLUTION NO. 2012-57

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION
TO THE U.S. DEPARTMENT OF JUSTICE FOR A DOMESTIC VIOLENCE
RESPONSE TEAM AND EXECUTE ALL DOCUMENTS NECESSARY TO
RECEIVE \$153,320 IN GRANT FUNDING**

WHEREAS, the U.S. Department of Justice administers the Office on Violence Against Women (OVW) grant program; and

WHEREAS, OVW is a grant program whereby grant funds are made available to agencies committed to reducing violence against women and administering justice for, and strengthening services to victims of domestic violence, dating violence, sexual assault, and stalking; and

WHEREAS, the safety of Elk Grove citizens is the City Council's primary concern; and

WHEREAS, the Elk Grove Domestic Violence Response Team will offer victims of domestic violence, dating violence, sexual assault and stalking support and advocacy; and

WHEREAS, the Elk Grove Domestic Violence Response Team will also pursue prosecution of those who commit such crimes.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) submit a grant application to the U.S. Department of Justice for a Domestic Violence Response Team; 2) execute all contracts, reports and other documents required for receiving such funds pursuant to the terms and conditions of the U.S. Department of Justice; and 3) amend the Police Department's revenue and expense budget in the amount of \$153,320 if awarded.


