## **RESOLUTION NO. 2012-104**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO REVIEW SUBORDINATION REQUESTS IN THE AFFORDABLE HOMEOWNERSHIP PROGRAM AND TO EXECUTE THE DOCUMENTS NECESSARY TO SUBORDINATE THE CITY'S INTEREST IN THE PROPERTY WHEN DEEMED ADVANTAGEOUS TO THE CITY

- WHEREAS, the Affordable Homeownership Program comprises affordable units in two developments built by William Lyon Homes and Beazer Homes; and
- WHEREAS, affordable units in each of the developments were subject to the terms of an Affordable Housing Agreement entered into in 2005 for William Lyon Homes and 2006 for Beazer Homes; and
- WHEREAS, the terms of the Affordable Housing Agreements provided for a 55-year affordability deed restriction on certain properties, which was effectuated through the recordation of an Individual Regulatory Agreement and Shared Appreciation Deed of Trust ("Implementing Documents") on the affected properties; and
- WHEREAS, the terms of the Implementing Documents did not contemplate the need for subordination of the City's interest in the property to allow refinancing beneficial to the homeowners and to the City; and
- WHEREAS, staff proposes to allow refinancing and subordination of the City's interest in affordable properties when deemed advantageous for the City; and
- **WHEREAS**, the Implementing Documents allowing refinancing and subordination may, from time to time, require amendments; and
- WHEREAS, the approval of the William Lyon Homes Affordable Housing Agreement allowed the City Manager to make modifications to the implementing documents, but the approval of the Beazer Homes Affordable Housing Agreement did not specifically allow modifications; and
- WHEREAS, this approval does not qualify as a "project" subject to the California Environmental Quality Act (CEQA) because it will result in no direct physical effect on the environment.
- NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to review subordination requests in the Affordable Homeownership Program, make modifications to the implementing documents as necessary, and to execute the documents necessary to subordinate the City's interest in the property when deemed advantageous to the City by the City Manager.
