

RESOLUTION NO. 2012-124

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR CONTRACT WITH INTERSTATE OIL COMPANY TO SUPPLY BULK AND CARD LOCK FUEL SERVICES FOR CITY OWNED VEHICLES (WITH AN OPTIONAL EXTENSION OF TWO ADDITIONAL YEARS) IN AN AMOUNT NOT-TO-EXCEED \$1,980,000


WHEREAS, the City provides Police Services, Transit Services, Code Enforcement, Facility Services and Integrated Waste Management within the City of Elk Grove requiring the use of unleaded gasoline and diesel fuel for daily operation; and

WHEREAS, the City has determined to have fuel delivered in bulk and to use card lock fueling facilities; and

WHEREAS, a Request for Proposals (RFP) for Bulk and Card Lock Fuel was solicited, and Interstate Oil Company was determined to be the lowest responsive, responsible supplier to the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year contract with Interstate Oil Company to provide bulk and card lock fuel services for City owned vehicles for a three-year period beginning July 1, 2012 in an amount not-to-exceed \$1,980,000 subject to the Elk Grove City Council's extension of two additional years.




