

RESOLUTION NO. 2012-134

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AMENDMENT WITH PROFESSIONAL LANDSCAPE SOLUTIONS, INC. OF SACRAMENTO FOR LANDSCAPING SERVICES TO INCLUDE THE RECENTLY CONSTRUCTED RAIN GARDEN PLAZA AND CORPORATION YARD EXPANSION LANDSCAPE AND AUTHORIZING AN EXPENDITURE OF FUNDS NOT-TO-EXCEED \$22,000 [FOR A TOTAL EXPENDITURE OF FUNDS OVER THE THREE-YEAR TERM OF THE CONTRACT NOT-TO-EXCEED \$70,000]

WHEREAS, landscape maintenance of the City's facilities is necessary in delivering service to the citizens of the City of Elk Grove; and

WHEREAS, in December of 2010 the City conducted a formal request for proposals to seek economies of scale and thereby complied with the competitive bid requirements within the City's contracts and purchasing ordinance (Elk Grove Municipal Code Chapter 3.42); and

WHEREAS, Professional Landscaping Solutions, Inc. of Sacramento met all of the criteria in the request for proposal that was determined most advantageous to the City and Contract No. C-11-038 was issued; and

WHEREAS, design and construction of the City's Rain Garden Plaza and Corporation Yard Expansion Project are complete; and

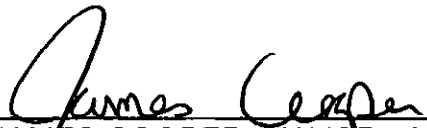
WHEREAS, Contract No. C-11-038 Scope of Work includes all landscaping areas of work that are directly adjacent to, and surrounding, the City Facilities including the parking areas. The Rain Garden Plaza is located adjacent to the City's 8380 and 8400 Buildings on Laguna Palms Way and the Corporation Yard area is an expansion of existing property both maintained by Professional Landscape Solutions, Inc. of Sacramento; and

WHEREAS, Professional Landscaping Solutions, Inc. of Sacramento has satisfactorily provided landscape maintenance to the City; and

WHEREAS, Facilities Services has sufficient funding identified in its Fiscal Year 2012-13 operating budget for this service.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract amendment with Professional Landscape Solutions, Inc. of Sacramento for landscaping services to include the Rain Garden Plaza and Corporation Yard Expansion landscaping and authorizing an expenditure of funds not-to-exceed \$22,000 *[for a total expenditure of funds over the three year term of the contract not-to-exceed \$70,000]*.
