

**RESOLUTION NO. 2013-2**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE SUPPORT FOR \$2,490,233 OF PROPOSITION 1B BOND  
FUNDS FOR THE REPLACEMENT OF THREE TRANSIT BUSES,  
THE REHABILITATION OF TWELVE TRANSIT BUSES AND  
ONBOARD SURVEILLANCE CAMERA SYSTEMS**

**WHEREAS**, the City of Elk Grove operates a comprehensive transit system; and

**WHEREAS**, the City has been awarded and will apply for Proposition 1B Transit-Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) funding to implement and support transit capital projects; and

**WHEREAS**, the City of Elk Grove is authorized to request \$2,300,000 towards the replacement of three 40 foot transit buses and the rehabilitation of twelve transit buses; and

**WHEREAS**, the City of Elk Grove is authorized to request \$190,233 towards the purchase and installation of onboard surveillance camera sets; and


**WHEREAS**, it is in the City's best interest to have a transit fleet with security features able to capture onboard events impacting rider and employee safety; and

**WHEREAS**, it is in the City's best interest to have a transit fleet size needed to sustain current levels of transit service in the City to meet transit needs; and

**WHEREAS**, the City of Elk Grove will request allocation of the funds through the California Department of Transportation, Division of Mass Transportation.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove authorizes the City Manager to submit an allocation request to the California Department of Transportation for PTMISEA funds to replace three 40 foot transit buses, the rehabilitation of 12 transit buses and purchase and installation of onboard surveillance camera sets and related installation costs.


