A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A PURCHASE REQUISITION WITH BRAZOS TECHNOLOGY FOR THE PURCHASE OF HANDHELD ELECTRONIC CITATION DEVICES IN AN AMOUNT NOT TO EXCEED \$87,000

WHEREAS, the Police Department issues an average of 20,000 handwritten citations annually; and

WHEREAS, handwritten citations take an average of eight to twelve minutes to complete, placing an officer at risk while he/she is outside the vehicle amid traffic during that time; and

WHEREAS, utilizing an electronic citation device takes less time than traditional handwritten citations and offers the public a more efficient and accurate recording of the citation; and

WHEREAS, efficiency and accuracy are important, the safety of police officers is paramount; and

WHEREAS, pursuant to Elk Grove Municipal Code Sections 3.42.180(B)(4) and 3.42.220, the City Council may dispense with the competitive bidding process for purchases greater than \$50,000.01 when the purchase is processed through a cooperative purchasing agreement; and

WHEREAS, the State of California General Services Administration (GSA) has secured the most competitive pricing for this particular commodity and this contract will be purchased through a cooperative purchasing agreement with GSA; and

WHEREAS, the Police Department has sufficient funding in its budget for this purchase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a purchase requisition with Brazos Technology for the purchase of handheld citation devices in an amount not to exceed \$87,000 through a cooperative purchasing agreement with GSA.
