REGARDING THE COLLECTION OF CERTAIN BUILDING AND PLAN CHECK FEES
ON BEHALF OF CCSD'S FIRE AND PARKS DEPARTMENTS**


WHEREAS, certain buildings and works of improvement within the City of Elk Grove require separate approvals from, and payment of fees to, both the City and the Cosumnes Community Services District (CCSD); and

WHEREAS, the City of Elk Grove and CCSD share the goal of streamlining the development authorization process within the City of Elk Grove and improving customer service; and

WHEREAS, the City of Elk Grove and CCSD have agreed to coordinate services to provide a consolidated option for review and fee payment by entering into a Memorandum of Understanding (MOU) authorizing the City to collect certain building and plan check fees on behalf of CCSD's Fire and Parks Departments.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a MOU with CCSD regarding the collection of certain building and plan check fees on behalf of CCSD's Fire and Parks Departments.


