

**RESOLUTION NO. 2013-48**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION TO THE  
U.S. DEPARTMENT OF JUSTICE AND TO EXECUTE ALL DOCUMENTS  
NECESSARY TO RECEIVE \$140,680 IN GRANT FUNDING FOR A DOMESTIC  
VIOLENCE RESPONSE TEAM**

**WHEREAS**, the U.S. Department of Justice administers the Office of Violence Against Women (OVW) grant program; and

**WHEREAS**, OVW is a program providing grant funds to agencies committed to reducing violence against women and administering justice for, and strengthening services to victims of domestic violence, dating violence, sexual assault, and stalking; and

**WHEREAS**, the safety of Elk Grove citizens is the Council's primary concern; and

**WHEREAS**, the Elk Grove Domestic Violence Response Team will offer victims of domestic violence, dating violence, sexual assault and stalking support and advocacy; and

**WHEREAS**, the Elk Grove Domestic Violence Response Team will also pursue prosecution of those who commit such crimes.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) submit a grant application to the U.S. Department of Justice for a Domestic Violence Response Team; 2) execute all contracts, reports and other documents required for receiving such funds pursuant to the terms and conditions of the U.S. Department of Justice; and 3) amend the Police Department's revenue and expense budget in the amount of \$140,680 if awarded.


