

**RESOLUTION NO. 2013-85**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING PER THE ELK GROVE MUNICIPAL CODE AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE NECESSARY DOCUMENTS TO AMEND THE CONTRACT WITH EMERGENCY VEHICLE OUTFITTERS OF ELK GROVE FOR THE INSTALLATION AND REPAIR OF EMERGENCY RESPONSE EQUIPMENT AND SAFETY LIGHTING FOR CITY VEHICLES, EXTENDING THE CONTRACT FOR TWO YEARS AND AUTHORIZING AN EXPENDITURE OF FUNDS NOT-TO-EXCEED \$530,000 [FOR A TOTAL COMPENSATION AMOUNT NOT-TO-EXCEED \$1,060,000]**

**WHEREAS**, the City of Elk Grove's Fleet division maintains City vehicles including mechanical, structural and aesthetic standards; and

**WHEREAS**, in June of 2010 the City conducted a formal request for proposals to seek economies of scale and thereby complied with the competitive bid requirements within the City's contracts and purchasing ordinance (Elk Grove Municipal Code Chapter 3.42); and

**WHEREAS**, Emergency Vehicle Outfitters of Elk Grove met all of the criteria in the request for proposal that was determined most advantageous to the City and contract C-10-212 was issued; and

**WHEREAS**, Transit staff has received grant funding for the installation and maintenance of on board camera systems. The systems include cameras, wiring, antennas, and recording servers and will require installation and maintenance. The camera systems require similar installation, and are similar in functionality to what is currently installed in the Elk Grove Police Department patrol vehicles by Emergency Vehicle Outfitters of Elk Grove; and

**WHEREAS**, Contract C-10-212 Scope of Work includes the installation and repairs of on board camera and two-way radio systems; and

**WHEREAS**, Emergency Vehicle Outfitters of Elk Grove has satisfactorily provided the installation and maintenance of emergency response and safety equipment in City vehicles; and

**WHEREAS**, Fleet and Transit Services has sufficient funding identified in its Fiscal Year 2012-13 operating budget for this service; and

**WHEREAS**, for the reasons presented, it is in the best interest of the City to dispense with the formal competitive bidding procedure under EGMC 3.42.180, in accordance with section 3.42.180(B)(3), for continued receipt of the goods and services described herein.

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove hereby determines that the compliance with formal solicitation and competitive bidding procedure is not in the best interest of the City and further authorizes the City Manager to execute the necessary documents to amend the contract with Emergency Vehicle Outfitters of Elk Grove for the installation and repair of emergency response equipment and safety lighting for City vehicles, extending the contract for two years and authorizing an expenditure of funds not-to-exceed \$530,000 [for a total compensation amount not-to-exceed \$1,060,000].


