**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE EMERGENCY OPERATIONS CENTER - TRAFFIC, CCTV TRAFFIC
MONITORING CAMERA INSTALLATION PROJECT (EOC002) AS COMPLETE
AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO
FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on March 27, 2013 the City Council authorized the award of a construction contract to 3D Data Com to construct the Emergency Operations Center Traffic, CCTV Traffic Monitoring Camera Installation Project (Capital Improvement Project ID EOC002) (Project); and

WHEREAS, the Project installed ten City-furnished CCTV traffic monitoring cameras on existing traffic signal poles at ten signalized intersections throughout the City; and

WHEREAS, 3D Data Com has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to 3D Data Com.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Emergency Operations Center Traffic, CCTV Traffic Monitoring Camera Installation Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
