

**RESOLUTION NO. 2013-202**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO SUBMIT THE NECESSARY DOCUMENTS TO THE CALIFORNIA OFFICE OF TRAFFIC SAFETY TO APPLY FOR GRANT FUNDING FOR CONCENTRATED TRAFFIC ENFORCEMENT STRATEGIES FOR A SOBRIETY CHECKPOINT PROGRAM AND AMEND THE POLICE DEPARTMENT'S FISCAL YEAR 2013-14 BUDGET TO APPROPRIATE GRANT FUNDS UP TO THE AMOUNT OF \$55,000 IF APPLICATION IS SELECTED FOR FUNDING**

**WHEREAS**, the California Office of Traffic Safety's (OTS) mission is to effectively and efficiently administer traffic safety grant funds to reduce traffic deaths, injuries, and economic loss; and

**WHEREAS**, OTS has recently invited local law enforcement agencies to apply for grant funding that will support and advance their mission; and

**WHEREAS**, the Elk Grove Police Department desires to continue its sobriety checkpoint program in support of OTS and the Department's philosophy of proactive law enforcement; and

**WHEREAS**, the safety of Elk Grove citizens is the Council's primary concern.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Submit a grant application to the California Office of Traffic Safety to receive up to \$55,000 in funding to implement concentrated traffic enforcement strategies; and
- 2) Execute all related award documents required for receiving such funds if the City is selected for funding pursuant to the terms and conditions of the California Office of Traffic Safety; and
- 3) Amend the Police Department's revenue and expense budget as follows, if grant funds are awarded:
