

RESOLUTION NO. 2014-11

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDED SUB-
RECIPIENT AGREEMENT WITH THE SACRAMENTO AREA COUNCIL OF
GOVERNMENTS (SACOG) AND SUBMIT FOR ALLOCATION FOR THE
REPLACEMENT OF THREE TRANSIT BUSES**

WHEREAS, the City of Elk Grove operates a comprehensive transit system; and

WHEREAS, the City has been allocated Proposition 1B Transit-Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) funding to implement and support transit capital projects; and


WHEREAS, SACOG awarded the City \$1,500,000 in PTMISEA regional funds for the replacement of three transit buses on January 9, 2013; and

WHEREAS, the City of Elk Grove authorized an additional \$100,000 for the replacement of three transit buses in PTMISEA regional funds at its August 28, 2013, City Council meeting through Resolution No. 2013-151; and

WHEREAS, savings from the GRTA Bus Rehabilitation Project and PTMISEA interest from SACOG in the amount of \$97,777 have been approved by the SACOG Board of Directors on September 26, 2013, to be used towards the remaining amount needed to fully fund the purchase of the three buses.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to execute the Amended Sub-recipient Agreement and submit for allocation totaling \$1,597,777 with the Sacramento Area Council of Governments and the City of Elk Grove for the replacement of three transit buses in substantially the form as attached.


