

RESOLUTION NO. 2014-73

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION TO THE
CALIFORNIA DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL FOR
CONCENTRATED ENFORCEMENT OF UNLAWFUL ALCOHOL USE AND EXECUTE
ALL DOCUMENTS NECESSARY TO ACCEPT UP TO \$88,000 IN GRANT FUNDING
IF SELECTED**

WHEREAS, in February 2014, the Department of Alcoholic Beverage Control announced funding opportunities for local law enforcement agencies interested in implementing programs that would allow them to expand their enforcement efforts in addressing alcohol-related problems; and

WHEREAS, the Elk Grove Police Department desires to submit a grant application that will provide officer overtime funding to establish a separate patrol unit that will focus on various strategies aimed at reducing unlawful use of alcohol; and

WHEREAS, the safety of Elk Grove citizens is the Police Department's primary concern; and

WHEREAS, this grant supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Submit a grant application to the California Department of Alcoholic Beverage Control for the purpose of reducing unlawful use of alcohol in Elk Grove; and
- 2) Execute all related award documents required for receiving up to \$88,000 pursuant to the terms and conditions of the California Department of Alcoholic Beverage Control; and
- 3) Amend the Police Department's FY 2013-14 and FY 2014-15 revenue and expense budget in a total not-to-exceed amount equal to the award amount up to \$88,000 combined for the two fiscal years after the award is received.




