**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FY 2014-15 ANNUAL BUDGET AND THE FY 2014-19 CAPITAL
IMPROVEMENT PLAN FOR \$2,300,000 TO DEVELOP A VETERANS HALL AT THE
CIVIC CENTER**

WHEREAS, the City will honor their service by dedicating a Veterans Hall at the
Civic Center; and

WHEREAS, the Veterans Hall will provide space for meetings, fellowship, offices,
displays, service coordination, training, event rentals and storage.


