

**RESOLUTION NO. 2014-275**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE PUBLIC WORKS DIRECTOR TO PREPARE AND SEND A  
“LETTER OF REQUEST” TO THE SACRAMENTO MUNICIPAL UTILITY DISTRICT  
REQUESTING UNDERGROUNDING OVERHEAD ELECTRICAL FACILITIES ALONG  
ELK GROVE BOULEVARD BETWEEN SCHOOL STREET AND WATERMAN ROAD**

**WHEREAS**, the City of Elk Grove has undertaken the Old Town Streetscape Project – School Street to Waterman Road, CIP ID# WTR012 (“Project”) to construct improvements that will improve aesthetics, public accessibility, economic vitality; and

**WHEREAS**, the City applied for and received a Community Design Grant from the Sacramento Area Council of Governments; and

**WHEREAS**, the undergrounding of overhead utilities is desirable; and

**WHEREAS**, the Sacramento Municipal Utility District (SMUD) will fund the cost to relocate or underground its facilities provided the City has:


- identified a project and determined the project is in the public interest,
- ensured the relocation of all telecommunications companies is funded and completed,
- completed plans and specifications for the relocation of SMUD’s facilities and has constructed the underground improvements to SMUD’s satisfaction,
- procured all required building permits and executed easements and services relocation agreements with all affected property owners; and

**WHEREAS**, the first step in the SMUD System Enhancement Program is to receive a Letter of Request signed by the local agency governing body; and


**WHEREAS**, the Letter of Request does not constitute a “project” that is subject to environmental review (CEQA Guidelines Section 15738) and is not a “project” under CEQA.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the Public Works Director to prepare and send a “Letter of Request” to SMUD requesting undergrounding overhead electrical facilities along Elk Grove Boulevard between School Street and Waterman Road.


