**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE
CALIFORNIA DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL AND AMEND
THE POLICE DEPARTMENT'S FISCAL YEAR 2015 AND 2016 BUDGETS TO
APPROPRIATE GRANT FUNDS IN A TOTAL AMOUNT OF \$16,600 FOR THE
PURPOSE OF REDUCING UNDERAGE DRINKING IN ELK GROVE**

WHEREAS, In August 2015, the Department of Alcoholic Beverage Control announced funding opportunities for local law enforcement agencies interested in implementing *Minor Decoy* and *Shoulder Tap* operations; and

WHEREAS, the Department of Alcoholic Beverage Control has awarded the Elk Grove Police Department a grant in the amounts of \$16,600 to implement programs to reduce underage drinking; and

WHEREAS, the safety of Elk Grove citizens is the Police Department's primary concern; and


WHEREAS, these grant funds will allow the Police Department to work additional hours to implement the *Minor Decoy* and *Shoulder Tap* operations throughout the City of Elk Grove; and

WHEREAS, this grant supports City Council's goal to foster and support the safest and most highly connected neighborhoods with diverse opportunities for urban and rural lifestyles.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Accept a grant award from the Department of Alcoholic Beverage Control in the amount of \$16,600; and
- 2) Execute all related award documents required for receiving such funds pursuant to the terms and conditions of the Department of Alcoholic Beverage Control; and
- 3) Amend the Police Department's Fiscal Year 2015 and 2016 revenue and expense budgets in a total amount of \$16,600 combined for the two fiscal years after the award is received.


