**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING PER THE PROVISIONS OF THE ELK GROVE MUNICIPAL CODE AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AMENDMENT WITH NEOGOV FOR AUTOMATED APPLICATION TRACKING AND RECRUITMENT SERVICES FOR AN ADDITIONAL FIVE YEAR TERM IN THE AMOUNT OF \$37,930, FOR A CONTRACT TOTAL NOT TO EXCEED AMOUNT OF \$87,471**


**WHEREAS**, the City contracts with NEOGOV for automated application tracking and recruitment services software applications; and

**WHEREAS**, automated application tracking and recruitment services provide cost savings, valuable resources and capabilities to Human Resources functions; and

**WHEREAS**, for the reasons presented, it is in the best interest of the City to dispense with the formal competitive bidding procedure pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3) for the services described herein.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby determines that compliance with the formal competitive bidding procedure is not in the best interest of the City for the services described herein and authorizes the City Manager to execute an amendment to the consultant contract with NEOGOV for automated application tracking and recruitment services for an additional five-year term in the amount of \$37,930 for a total not to exceed amount of \$87,471.00.
