RESOLUTION NO. 2017-131

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A SERVICE AGREEMENT WITH SACRAMENTO REGIONAL TRANSIT DISTRICT (RT), FOR A THREE-YEAR TERM WHICH WILL EXPIRE ON JUNE 30, 2020; AND A FINDING THAT COMPLIANCE WITH THE FORMAL SOLICITATION PROCEDURE IS NOT IN THE BEST INTEREST OF THE CITY, IN ACCORDANCE WITH ELK GROVE MUNICIPAL CODE SECTION 3.42.180(B)(2)

- WHEREAS, the City of Elk Grove (City) and Sacramento Regional Transit District (RT) have had a service agreement since December 2004; and
 - WHEREAS, the Service Agreement will expire on June 30, 2017; and
- **WHEREAS**; the term of the new agreement is for a three-year period, July 1, 2017-June 30, 2020; and
- WHEREAS, during the term of the agreement the City continues representation on the RT Board as provided under California Public Utilities Code Sections 102100.3, et seq.; and
- **WHEREAS**, the during the term of the agreement the City's annual payment to RT will be \$350,000; and
- **WHEREAS**, the Service Agreement contains the same fundamental provisions as the prior Agreement; and
- WHEREAS, RT is the sole provider of the regional transit system that the City's current transit service connects to in order to address the City's residents' current service needs/travel demands; and
- WHEREAS, for the reasons presented seeking competitive proposals for the proposed transit services is not in the best interests of the City.
- NOW, THEREFORE, BE IT RESOLVED that the City Council finds that pursuing competitive proposals for the proposed transit services is not in the best interest of the City, that the City Council dispenses with such proposal process in accordance with Elk Grove Municipal Code Section 3.42.180(B)(3), and the City Council authorizes the City Manager to execute a Service Agreement with Sacramento Regional Transit in substantially the same form presented to City Council.
