## **RESOLUTION NO. 2018-015**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CREDIT REIMBURSEMENT AGREEMENT WITH THE RIDGE EG EAST, LP, FOR PRIVATELY CONSTRUCTED PUBLIC FACILITIES INCLUDED IN THE ELK GROVE ROADWAY FEE PROGRAM IN SUBSTANTIALLY THE FORM PRESENTED, AND AMENDING THE FISCAL YEAR 2017-18 BUDGET TO REFLECT THE EXPENSES AUTHORIZED IN THE AGREEMENT

WHEREAS, Elk Grove Municipal Code Section 16.95.070 provides for reimbursement to developers for the private construction of any facilities designated in the Roadway Fee Program subject to entering into a reimbursement agreement with the City of Elk Grove; and

**WHEREAS**, The Ridge EG East, LP, is constructing a segment of Elk Grove Boulevard to modify an intersection and add left turn lanes, which segment is included in the Roadway Fee Program; and

**WHEREAS**, a budget amendment is necessary to reflect the expenses authorized in the agreement and there is sufficient Roadway Fee Fund Reserves to fund the issuance of Roadway credits.
