## **RESOLUTION NO. 2018-023**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CREDIT REIMBURSEMENT AGREEMENT WITH TAYLOR MORRISON OF CALIFORNIA, LLC, FOR PRIVATELY CONSTRUCTED PUBLIC FACILITIES REQUIRED AS A CONDITION OF APPROVAL FOR THE FINAL MAP FOR SUBDIVISION NO. 13-052, POPPY KEYS EAST, WHICH FACILITIES ARE INCLUDED IN THE ELK GROVE ROADWAY FEE PROGRAM, AND AMENDING THE FISCAL YEAR 2017-18 BUDGET TO REFLECT A PORTION OF THE EXPENSES AUTHORIZED IN THE AGREEMENT

WHEREAS, Elk Grove Municipal Code Section 16.95.070 provides for reimbursement to developers for the private construction of any facilities designated in the Roadway Fee Program subject to entering into a reimbursement agreement with the City of Elk Grove; and

WHEREAS, Taylor Morrison of California, LLC is constructing a segment of Whitelock Parkway fronting the Reardan Community Park and the Poppy Keys East subdivision, which are facilities required as a Condition of Approval for the Poppy Keys East subdivision, which facilities are included in the Roadway Fee Program; and

**WHEREAS**, a budget amendment is necessary to reflect the expenses authorized in the agreement and there are sufficient Roadway Fee Fund Reserves to fund the issuance of Roadway Fee Credits.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Credit Reimbursement Agreement with Taylor Morrison of California, LLC, in substantially the form presented, for reimbursement by way of credits against future fees from the Elk Grove Roadway Fee Program; and

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes an amendment to the FY 2017-18 Budget from the Elk Grove Roadway Fee Program to establish the eligible fee credits, and direct a contribution from the Roadway Fee Reserve for the amount of the budget adjustment of \$669,824.
