A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ESTABLISHING A PREFERENTIAL PARKING PERMIT ZONE (PPPZ) ON MINNIE CIRCLE

WHEREAS, on October 8, 2014, the City of Elk Grove (City) adopted Ordinance No. 27-2014 to allow for Preferential Parking Permit Zones (PPPZ), which is codified at Elk Grove Municipal Code (EGMC) Chapter 10.26; and

WHEREAS, residents of Minnie Circle in the area near Elk Grove High School are experiencing limited available parking near their homes during various hours of the day and evening while school is in session, or when events are occurring; and

WHEREAS, more than 75% of the residents on Minnië Circle have signed a petition requesting to have their street established as a PPPZ; and

WHEREAS, the request satisfies the requirements of Elk Grove Municipal Code (EGMC) Chapter 10.26; and

WHEREAS, staff from both Public Works and the Police Department have reviewed the request and recommend establishing a PPPZ on Minnie Circle.

NOW, **THEREFORE**, **BE IT RESOLVED** by the City Council of the City of Elk Grove that a Preferential Parking Permit Zone is hereby established on Minnie Circle pursuant to EGMC Chapter 10.26, as indicated on the attached Exhibit A, incorporated herein by reference, with preferential parking permits to be issued by the Public Works Director or designee.
