

RESOLUTION NO. 2019-136

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
UPDATING THE SCHEDULE OF FINES RELATED TO ADMINISTRATIVE
CITATIONS IN THE CITY OF ELK GROVE**

WHEREAS, on May 25, 2005, the City Council of the City of Elk Grove adopted Resolution No. 2005-151 establishing the City's current fine schedule related to administrative citations; and

WHEREAS, on April 8, 2009, the City Council adopted Ordinance No. 7-2009, creating Elk Grove Municipal Code Chapter 1.12, Administrative Citations; and

WHEREAS, the City Council wishes to update the schedule of administrative fines for violations of the City's Municipal Code.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Repeals Resolution No. 2005-151 in its entirety, including the Schedule of Fines attached thereto. Notwithstanding the repeal of Resolution 2005-151, any citation or administrative fine imposed or issued under Resolution 2005-151 prior to the date of this Resolution shall remain valid and enforceable; and
- 2) Approves this Resolution, including the updated Schedule of Administrative Fines attached as Exhibit A and incorporated herein by reference. Any person who fails to pay a fine identified on Exhibit A when due shall be liable for a penalty in the amount of ten percent (10%) of the fine. In addition to any penalties, any person who fails to pay a fine when due shall be liable for interest on the fine at a rate of one and one-half percent (1½%) per month or portion thereof, of the fine (exclusive of penalties) from the date the fine is due until paid.

EGMC Title	EGMC Chapters/Sections	Administrative Fine Amounts
Title 15 Water and Sewers	Fines for violation of Chapter 15.12 Stormwater Management and Discharge Control	Each violation \$1000
Titles not specifically listed	Fines for violation of any other section of the Elk Grove Municipal Code for which a specific fine or penalty is not specified.	1st violation: \$100; 2nd violation of the same code section within one year within one year of the date of the first violation: \$200; 3rd and subsequent violations of the same code section within one year within one year of the date of the first violation: \$500

Effective: June 26, 2019

In the event the administrative fine amounts set forth in this Schedule of Administrative Fines exceed the amount the City is authorized to assess by California state law, then the maximum administrative fine amount shall be that amount authorized by state law.
