

**RESOLUTION NO. 2019-177**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCESS PURSUANT TO ELK GROVE MUNICIPAL CODE CHAPTER 3.42.140(B) (3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE THIRD AMENDMENT TO THE CONTRACT WITH ROEBBELEN CONSTRUCTION MANAGEMENT SERVICES, INC. FOR SERVICES RELATED TO THE AQUATICS/COMMONS AND COMMUNITY CENTER PROJECTS INCREASING THE TOTAL AMOUNT BY \$140,000 [FOR A TOTAL CONTRACT NOT-TO-EXCEED AMOUNT OF \$2,692,365]**

**WHEREAS**, The City contracted with Roebbelen Construction Management Services, Inc. ("Roebbelen") in 2016 to provide construction management services for the Aquatics/Commons and Community Center projects ("Project"); and

**WHEREAS**, due to the schedule of the Project being extended two months, Roebbelen will need an amendment to their existing contract; and

**WHEREAS**, for the reasons presented, pursuing competitive proposals for the proposed services is not in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposals process pursuant to Elk Grove Municipal Code section 3.42.140(B)(3) and authorizes the City Manager to execute the third amendment to the contract with Roebbelen Construction Management Services, Inc., in substantially the form presented, for services related to the Aquatics/Commons and Community Center projects, increasing the total contract amount by \$140,000 [*for a total contract not-to-exceed amount of \$2,692,365*].
